*Advanced Course in Ethics*, 7,5 ECTS, spring 2007. (course director) An advanced introduction to contemporary debates in moral philosophy, revolving around a set of classic papers in moral philosophy from the last 25 or so years.

*Technology and ethics*, 7,5 ECTS, fall 2006 and spring 2007. (Course director) This course introduces moral philosophy and gives an overview of ethical problems concerning technology.

*Ethics for engineers*, 7,5 ECTS, spring 2007. (Course director) The focus of this course is also moral philosophy and the ethics of technology.

*Introduction to the Professional Ethics of Engineers*, 3 ECTS, spring and fall 2005. (Course director) This course segment (five lectures and two seminars) was an introduction to ethics with applications to the ethics of engineering.

*Management Ethics*, 7,5 ECTS, fall 2005 and 2006. I have had responsibility for supervising the students in their writing of term papers and holding the seminars on this course in business ethics for three times.

During 2012-2015, I was in charge of organizing yearly two-day study trips to Stockholm for the students of the Program for Philosophy and Social Analysis at Umeå University to visit philosophers working outside of academia.

### *Course development*

*AI and Ethics*, 7,5 ECTS. This course introduces ethical issues with regards to AI. It will be given as both a campus and an online course.

*The Philosophy of Education*, 7,5 ECTS, This course was given on the Internet only. It deals with the philosophy of education, with some emphasis on issues related to political philosophy.

*The Methodology and Ethics of Science*. This course was developed in cooperation with, and given at the Swedish University of Agricultural Sciences. I was in charge of the parts dealing with the philosophy of science.

*Risk and Rationality*, 7,5 ECTS. A course on the fundamental aspects of decision theory and the philosophy of risk. Developed for the Program for Philosophy and Social Analysis.

*Dworkin's Political Philosophy and Ethics*, 7,5 ECTS. A course on Ronald Dworkin's "Justice for Hedgehogs". This was the first advanced course given at the department to be given on the Internet. It was developed as to serve as a template for further advanced distance courses on this level.

*Reading Courses on the Advanced Level*, 7,5 ECTS. I have developed 10 reading courses. For each course I have selected a main book and other readings on an important subject in philosophy.

*Research Ethics for Historians*. This course was developed together with historians and had a focus on ethical issues with regards to research on education.

*The Philosophy of Social Science*, 7,5 ECTS. This course had a specific focus on the philosophy of economics. It was developed for the Program for Philosophy and Social Analysis. Major revisions fall 2014.

*Philosophy and Policy Analysis*, 7,5 ECTS. The course was developed for the Program for Philosophy and Social Analysis. It deals mainly with issues in applied political philosophy.

*Democracy, Individual, Society*. On this introductory course on the Teacher Training program, I developed two lectures on democracy.

*Advanced Philosophical Writing*, 7,5 ECTS. I redeveloped this course, with the result that a much higher degree of students finished their theses in time, and with good quality.

*Philosophical Writing*, 7,5 ECTS. I redeveloped this course, with the result that a much higher degree of students finished their theses in time, and with good quality.

*Modern Political Philosophy*, 7,5 ECTS. This course focuses on the political philosophy of John Rawls and on contemporary debates on the concept of social justice. In seminars the

students will work on applying theories of justice to political problems. I revised this course during 2014.

*Introduction to Academic Studies, 7,5 ECTS.* I developed ten different seminars covering the basic academic skills required of students. The topics ranged from academic writing, via the philosophy of science, to ethical evaluation of infrastructure projects. These seminars are used at Luleå University of Technology to introduce their students to the academy.

*Philosophy and Film, 7,5 ECTS.* This course used films such as “The Matrix” and “Thank You for Smoking” to introduce some basic concepts and areas of philosophy.

*Controversial Technologies, 7,5 ECTS.* In collaboration with colleagues from the Division of the History of Technology at KTH, I laid the groundwork for course that will introduce the philosophy of risk through historical examples of controversial technologies.

*Management Ethics, 7,5 ECTS.* I was involved in deciding the content of this course so that it would cover all major areas of business ethics.

*The Political Philosophy of John Rawls, 7,5 ECTS.* I developed and organized this Ph D-level course, which was taken by about fifteen other Ph D students. I also served as a course assistant.

Other tasks have included designing tests, developing role-play seminars and creating cases for courses in applied ethics for a variety of courses. I have used Internet tools in several ways, such as having invited lecturers speak via the Internet, held seminars via link, and developed new ways of delivering long distance education.

### *Thesis Supervision*

I have supervised about fifty students, on both undergraduate and advanced levels. Many of these theses have been on political philosophy, but others have been on topics such as immaterial property rights, the relation between rationality and self-interest, happiness research, continental philosophy, environmental ethics, epistemology and ethical technology assessment.

I supervised the first thesis in the department at Umeå University that was written in collaboration with a company.

I am at present assistant supervisor for a Ph D student writing on public reason in political philosophy.

I have been an assistant supervisor for a graduate student writing on codes of ethics in finance, who published a licentiate thesis.

I served as one of two tutors for a Ph D student in work science, who has now submitted her paper to a peer-reviewed journal. The paper was on implicit contracts as a foundation of business ethics.
