## Research

My main research interest looks at the role of everyday experience in socio-political change. This approach connects with a variety of academic fields, and even more importantly, it forces them to intersect in a creative and productive ways. The academic disciplines that my doctoral thesis

engaged with include critical migration studies, post-structural philosophy, political economy of higher education, critical social psychology and the feminist methodological approach called collective memory-work. My reflexive stance towards academic practice is that politics, research methodologies and theoretical influences should strive to be consistent with each other. This interest has led me to experiment with and explore different methodological approaches including, ethnography and interviews. In depth I have worked with collective memory work, organizing workshops, participating in conferences and co-creating a Nordic network of collective memory-work scholars.
