### Research supervision

This course is intended for persons who have a doctoral degree and undertake supervision or co-supervision of PhD students.

#### Course in Higher Education

The course consists of two parts: a part that is common to the entire university, and a faculty-specific part. Information about the faculty-specific parts is given at the bottom of this page, and participants should contact the person who is responsible for the part given at their faculty.

The cross-university part (corresponding to 2 weeks) concerns learning processes and the development of personal skills in relation to experience. This part covers also research into higher educational pedagogy in the field of research supervision.

The faculty-specific parts (corresponding to 1 week) concern the rules, practices, study plans and action plans, the value of higher education based on gender equality, equal opportunities, and sustainable development, the cultures and work methods of third cycle education, and the areas of responsibility of the faculty offices' and faculty and PhD education boards, the faculties view of PhD education, and the requirements for qualifications.

At the Faculty of Medicine, issues relating to supervision in problem-based learning (PBL), student-centered learning and integration between subjects, programs, research and professions are discussed.

External participants who have no connection to LiU may participate in the cross-university part of the course, corresponding to 2.5 credits. The only faculty-specific part that external participants may participate in is the one given by the Faculty of Medicine and Health Sciences.
