Information regarding deferment of studies

Reasons for deferment of studies

A person who is admitted to a course or study programme must commence their studies in the semester referred to in the admission decision. If that person is unable to do so, they may on certain conditions be granted deferment of studies. A person who has already commenced studies (registered on a course or study programme) can normally not be granted deferment; they are instead advised to request a leave from studies.

Deferrals are regulated in Chapter 7, Section 33 of the Higher Education Ordinance (1993:100) and in the Swedish Council for Higher Education's regulations on deferment of studies for admitted students (UHRFS 2013:3) https://www.uhr.se/globalassets/ uhr.se/publikationer/lagar-och-regler2/uhrfs/konsoliderad-version-uhrfs-2013 3.pdf

The regulations mentioned above contains which circumstances can be ground for deferment, such as social, medical, or other extenuating circumstances such as:

- the care of a child
- mandatory military service
- denied leave of absence for studies from your employer
- assignment within a student union

Deferment can be granted for a maximum of 18 months unless there are extraordinary reasons for a longer time. Deferment can be given even if the applicant has been conditionally admitted.

The application

The application for deferment should be made as soon as the student becomes aware of any hindrance to the commencement of studies. The person applying for deferment must remain 'admitted' in the final selection round. For persons admitted in the first selection round, a YES must be given before second selection round, in the normal manner. An application for deferment can only cover one course/programme.

Your reasons for deferment are tested individually. The cited circumstances which you give as your reason for needing deferment must be substantiated with documentation.

Application for deferment is made via this form, which is submitted, together with documentation that substantiates the cited circumstances, to the Admissions office at:

All documentation that substantiates the cited circumstances should be submitted within a week of submitting this form.

The decision is conditional: new application is required

In order to claim you place you have to apply again to the course or study programme for the semester for which your deferment was granted. The new application is done according to the standard procedure and before the application deadline on universityadmissions.se or via post. You should also submit a copy of the decision granting you deferment either by uploading it on your page at universityadmissions.se or by sending it to: PostNord Strålfors AB, Att: Antagningsservice, R 312, 190 81 Rosersberg.

If you do not submit a new application, you will lose your place. You will also be deleted from the LiU option should you be accepted onto a higher priority selection.
